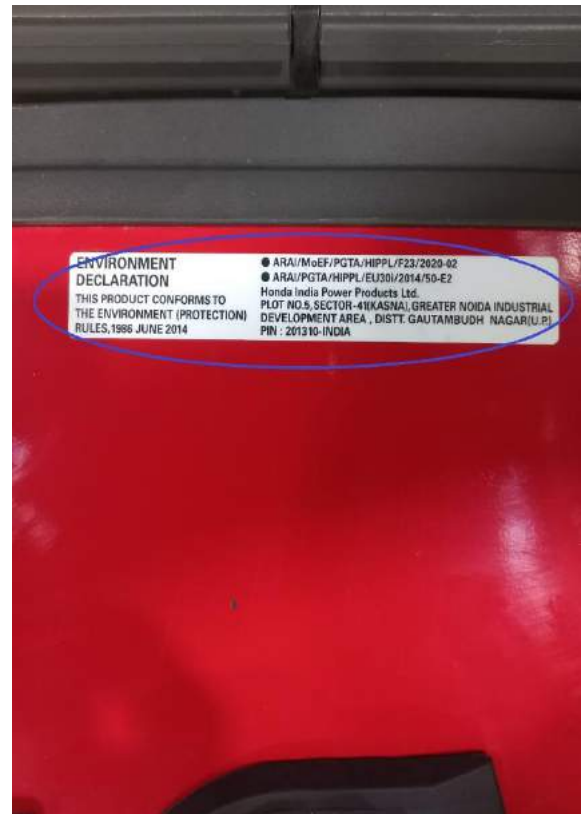

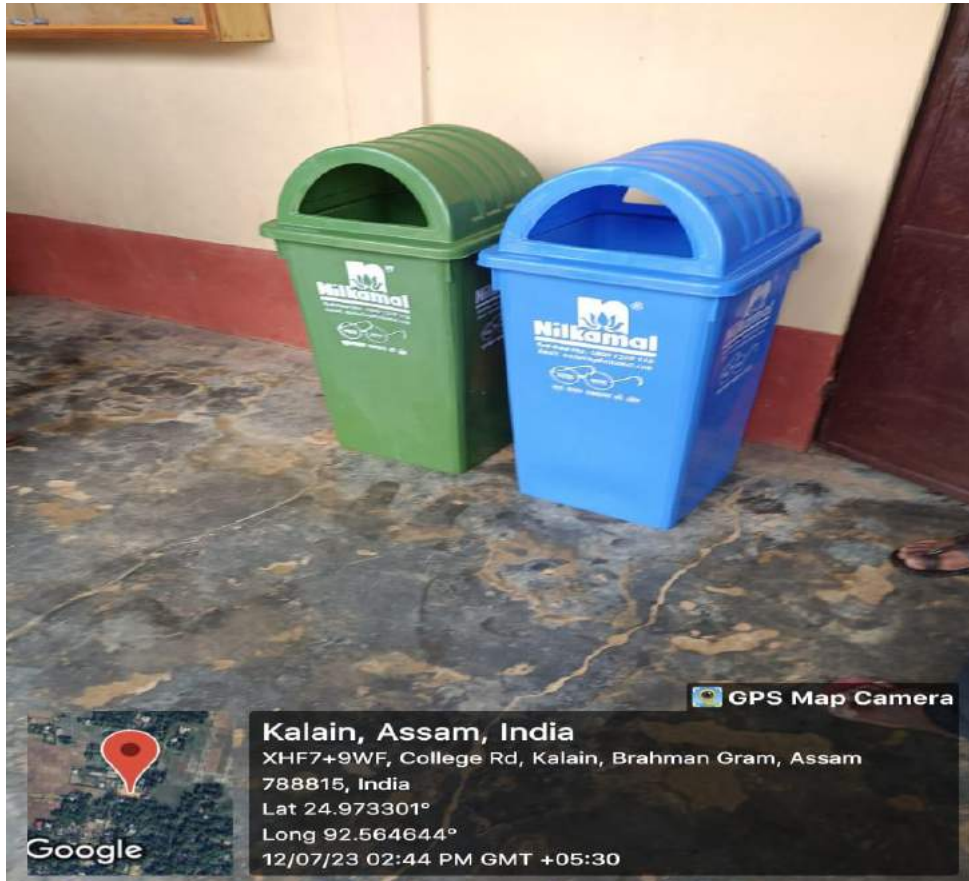

**MEMORANDUM OF UNDERSTANDING (MoU)**

**FOR MATTERS RELATING TO GARBAGE DISPOSAL & SOLID WASTE MANAGEMENT**

This is a Memorandum of Understanding signed on dated 31<sup>st</sup> Dec 2020 at Kalain, Cachar between Satya Ranjan College, Kalain, represented by the Principal, Dr. Bijit Goswami, referred as first party of the first part and President of Kalain Gaon Panchayat, represented by Sri Mridul Kanti Chakrabarty referred as second party of the second part, for the collection and disposal of garbage & solid waste products generated from the college campus in a proper way.

Satya Ranjan College produces a sufficient amount of waste products both biodegradable and non-biodegradable on an everyday basis, which is generally disposed into the separate dustbin/container. The college has a canteen from which waste products like waste food and other things are also generated. The college also manages xerox machine and printers for printing and managing official works, hence releasing paper wastes and some amount of E-waste. Since the college is committed to create a green zone, pollution free and eco-friendly campus, the authority is keen to keep its campus neat and clean. To serve this purpose, Satya Ranjan College has entered into an agreement with the Kalain Gaon Panchayat, Kalain for managing its waste products.

### TERMS AND CONDITIONS

Both the parties have agreed upon the following terms and conditions:

1. To collect the Solid waste & garbage, the Kalain Gaon Panchayat will provide two separate containers one each for biodegradable and non-biodegradable products.
2. The Gaon Panchayat will send vehicle to collect garbage from the college on a two days per weekly basis.
3. The garbage collector will also collect the scattered garbage outside the college i.e., near the gate, near the walls and the road.
4. The Kalain Gaon Panchayat will also manage spraying of chemicals like bleaching powder in the college campus to kill germs and maintain hygiene.
5. The garbage bin must be change from time to time whenever required by the College.
6. The Kalain Gaon Panchayat will always respond to the queries and feedback given by the authorities of Satya Ranjan College.

7. The Kalain Gaon Panchayet will always cooperate with Satya Ranjan College in organizing any sort of awareness programme related to waste management and hygiene.
8. This MoU will be a period of 3 years from the date of signing by both the parties.

Aspects related to the payment/fees etc. for the service (if any) will be decide by mutual consent of both the parties from time to time.

In witness thereof, both the parties have agreed upon the above-mentioned terms and conditions and signed the MoU on aforesaid date mentioned i.e., on 31<sup>st</sup> Dec 2020.

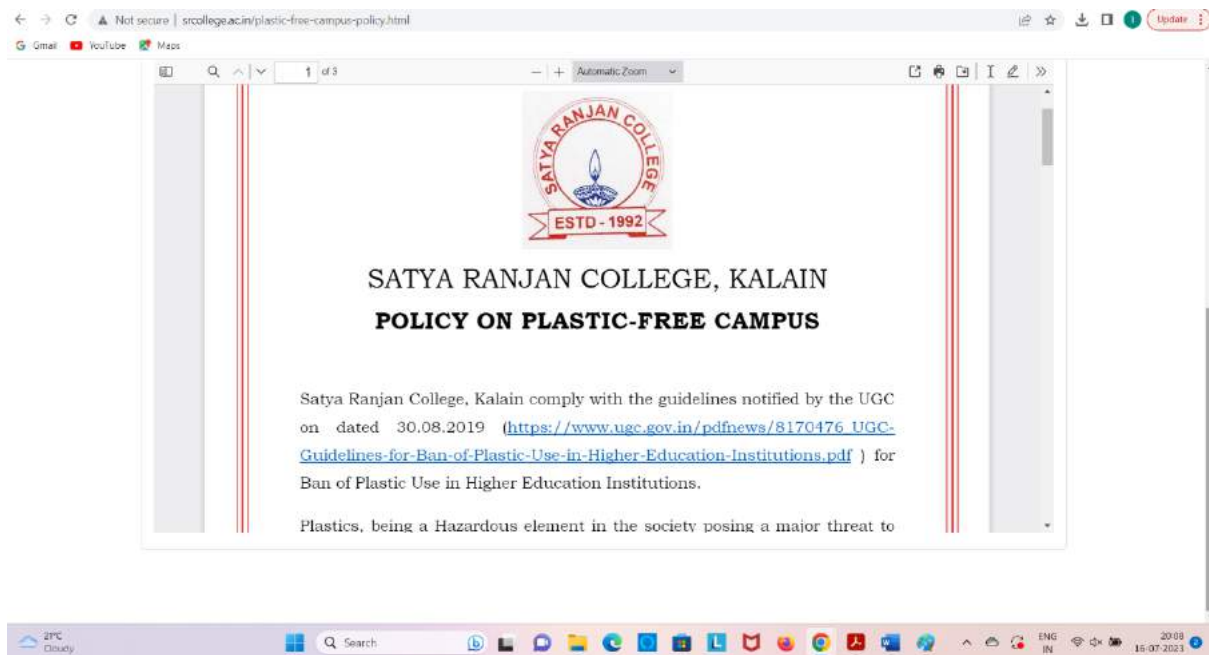

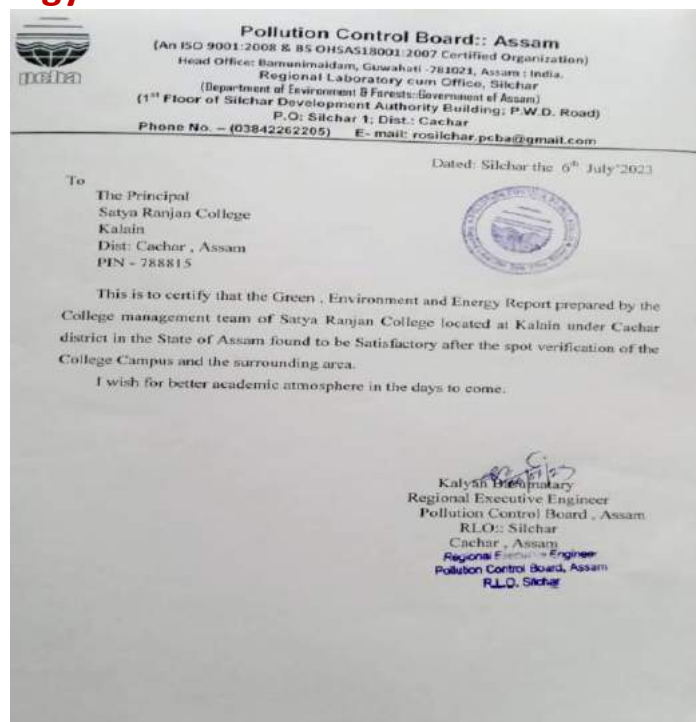
